EXHIBITION RULES AND REGULATIONS

ICEEP reserves the right to prohibit any exhibit, part thereof, or proposed exhibit that, in its opinion, is not suitable or in keeping with intentions and/or purposes of the organization.

1. Exhibition space

The cost of each exhibition space includes one table, two chairs and daily teas and lunches for two company representatives. Space allocated will be 2x3m. Exhibits shall be so arranged as not to obstruct the general view, nor hide the exhibits of others.

2. Security

The venue will provide perimeter guard service during the hours the exhibit area is opened and closed; however, Exhibitor is solely and fully responsible for its own exhibit material and stand contents, and should insure its exhibit against loss or damage from any cause whatsoever. All property of the Exhibitor is understood to remain in its care, custody and control in transit to or from within the confines of the exhibit hall.

3. Liability

Upon approval of this contract by an authorized Exhibitor representative, it is expressly understood that the Exhibitor has read and agrees to abide by the ICEEP liability policies outlined below. ICEEP, and all organizations and individuals who are employed by or associated with it, in connection with this Exhibition, will not assume responsibility and shall be held harmless by all Exhibitors for damage or loss resulting from fire, theft, or any other cause whatsoever, including accident or injury to exhibitors, their employees and agents, the public, or others. The Exhibitor agrees to pay promptly for any and all damages to the exhibition building or its equipment incurred through carelessness or otherwise, of Exhibitor or its employees or agents.

4. Insurance

ICEEP or the venue does not maintain insurance covering EXHIBITOR'S property or employees. It is the sole responsibility of the EXHIBITOR to obtain public liability insurance, business interruption insurance, property damage insurance, and workers' compensation insurance covering and protecting EXHIBITOR against all such losses as referenced in these Guidelines.

5. Exhibitor Badges

The payment for each 3 x 2m exhibition space will include up to two (2) complimentary conference exhibitor badges for employees. Additional badges must be purchased. All requested name badge changes must be made at the time badges are issued at the conference. Badges may not be returned and exchanged once they have been

issued.

6. VAT ruling*

VAT ruling from South African Revenue Services (SARS), which confirms that under certain circumstances, VAT for services supplied to foreign exhibitors can be zero-rated.

The important tests are as follows:

- The services must be supplied to an entity that is not resident in South Africa
- The foreign entity must not be registered or must not be required to register for VAT in South Africa
- The foreign entity must not carry on any enterprise in South Africa
- The goods are rented or services are supplied for use exclusively in an enterprise carried on in an export country
- The payment of the rent is effected from the export country

If these conditions are present then VAT may be levied at a rate of zero percent.

7. Payment schedule

Non-refundable, non-transferable deposit of 25% is due at least 10 days from the date this signed agreement is received by Vetlink to reserve your exhibition space. The balance must be paid on or before 1 February 2010. If the balance due is not paid on or before this date, the conference organiser reserves the right, without further notice, to reduce or release said space to other exhibitors. No space will be reserved or assigned unless both the deposit and signed contract are received at the ICEEP appointed organisers (Vetlink Conferences).

8. Alcohol serving and consumption

Exhibitors are not permitted to serve alcohol from and/or within the confines of their booth space nor within the exhibition hall, without written permission from the conference organisers and a signed service agreement.

9. Cancellation / Space Reduction

Any cancellation, space reduction requests, or requests for changes of this contract must be made in writing and forwarded to the ICEEP organisers at PO Box 232, Groenkloof, SOUTH AFRICA, 0182 or vetlinkinfo@mweb.co.za.

Cancellations or space reductions will be subject to charges according to the following schedule:

- More than six months before conference start date, by 7th May 2010 – Eligible for full refund.
- More than 120 days and less than six months before conference start date, 7th May 2010 through 7th July 2010 – Deposit forfeited; excess of deposit paid will be refunded in full.

- 120 days and less before conference start date, after 7th July 2010 – Full amount of fee is due.

In the event of cancellation or reduction of contracted space, and subject to the above cancellation charges schedule, ICEEP shall retain the right to resell cancelled space without rebate or allowance to the Exhibitor.

10. Termination of Exhibition

In the event that the premises in which the Exhibition is or is to be conducted shall become, in the sole discretion of ICEEP, unfit for occupancy, or in the event the holding of the Exhibition or the performance of ICEEP under the Exhibit Reservation Contract (of which these Rules and Regulations are a part) are substantially or materially interfered with by virtue of any cause or causes not reasonably within the control of ICEEP, said Contract and/or the Exhibition (or any part thereof) may be terminated by ICEEP. ICEEP shall not be responsible for delays, damage, loss, increased costs, or other unfavourable conditions arising by virtue of cause or causes not reasonably within the control of ICEEP. If ICEEP terminates said Contract and/or the Exhibition (or any part thereof) as aforesaid, then ICEEP (or its representatives) shall not be liable to the Exhibitor other than for a prorated refund of such Exhibitor's space price payment determined on the basis of the number of Exhibition days remaining. For purposes hereof, the phrase "cause or causes not reasonably within the control of ICEEP" shall include, but not by way of limitation: fire, casualty, flood, epidemic, earthquake or inclement weather; explosion or accident; blockade or embargo; governmental restraints; restraints or orders of civil defence or military authorities; terrorism or threat of terrorism, act of public enemy, riot, or civil disturbance; strike, lockout, boycott, or other labour disturbance; inability to secure sufficient labour, technical, or other personnel; failure, impairment, or lack of adequate transportation facilities; inability to obtain, or condemnation, requisition, or commandeering of necessary supplies or equipment; local, state, or Federal law, ordinances, rule, order decree, or regulation, whether legislative, executive, or judicial, and whether constitutional or unconstitutional; or Acts of God.
